1. Apologies for absence

4. Update on Neighbourhood Plan consultation held 16/17 March 2019

A discussion was had regarding the feedback received from the consultation. Approximately 100 people attended over the two days. B.Mackenzie spoke about the results received via questionnaires regarding sustainability. S.Adcock spoke about the results received via questionnaires regarding open space and a community centre. D.Woodham spoke about the results received via questionnaires regarding the overall design and I.Hetherington spoke about the results received via questionnaires regarding Housing. J.Lawton is currently collating the responses that were written on post it notes on boards relating to the same topics. These will all be available to view on the LSNP website soon.

5. To discuss and decide on materials for consultation at the Leisure centre

A discussion was had regarding the next public consultation being held at the Long Stratton Leisure Centre. This will take place on Tuesday 9th April, Wednesday 10th April and Thursday 11th April between 6pm and 8pm.
